## Equifax Data Breach



On September 7 it was announced that credit bureau, Equifax® was attacked by a cybersecurity breach that resulted in the exposure of an estimated 143 million consumers' private information, not including those impacted in the UK and Canada. The data includes their consumers' names, SSNs, birth dates, addresses and driver's license numbers, as well as 209,000 stolen card numbers and private data from 182,000 stolen dispute documents.

For information on how to mitigate risk, here are some helpful Mitigation Measures”:

- ◆ To determine if you were affected by the “hack” go to <https://trustedidpremier.com/eligibility/eligibility.html>
- ◆ Monitor all credit and loan accounts to determine if there is suspicious activity. If so, immediately report the activity to the financial institution.
- ◆ Sign up for fraud alerting services offered by the three major credit bureaus to receive notifications about potentially fraudulent activity.
