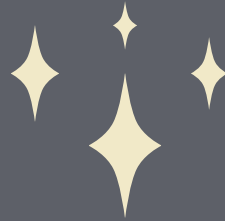

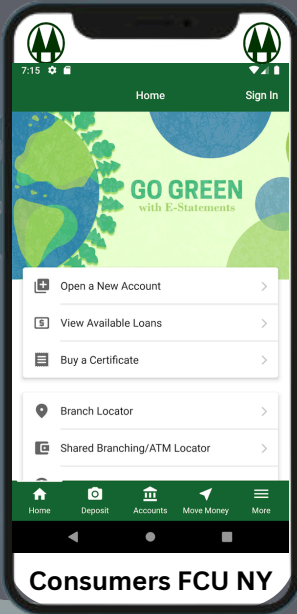
We have expanded our Co-Op shared branching network to add over 30,000 surcharge free ATMs and over 5,600 shared branches.
